NOTIFICATION

In order to provide Government to Citizen (G2C) Services to citizens under e-District Pilot Project being implemented in Ganjam and Mayurbhanj districts of Orissa through Common Services Centres (CSCs), the Government have been pleased to notify the electronic filing, receipt, processing and delivery of certificates under the Section 6A of "The Information Technology (Amendment) Act, 2008' in the manner laid down as under:

- Under e-District the List of Services and Service Specific Statutory Government Fees will be as to be notified by Department of Information Technology / Other State Govt. Departments, which can be revised from time to time.
- Apart from Statutory Government Fees, CSC Operator will also collect Service Charges as indicated below, which can be revised from time-to-time.

- NB:(i) The CSC Operator has to collect Rs.10 from the Applicant during Filling of Application and collect the balance Rs.10/- at the time of Delivery of Certificate.
 - (ii) The acknowledgement of receipt of Application / Delivery of Certificate and Payments received from the citizens shall be issued free of cost by the CSC Operator to the citizens.
 - (iii) Scanning Fees per page = Rs.5/- at CSC
 - (iv) Printing Fees per page = Rs.10/- at CSC
 - (v) No fees has to be paid by the citizen for filling Grievance (maximum 2 times per Service for the services availed through the same CSC), but for printing acknowledgement if required by the citizen for this purpose usual printing charges will be applicable.

CSC - Common Services Centre (Jana Seva Kendra)

DeGS - District e-Governance Society

- The Scanning and printing charges for attachments shall be collected extra from the applicant by the CSC Operator / VLE as indicated above.
- The CSC Operator / VLE will deposit the Statutory Government Fees in the respective Tahasils / Concerned Office as may be communicated by Department of Information Technology / Other State Government Departments from time to time.
