#### 1. Terms & Conditions:

- A) The tender received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible.
- B) Tender must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation.
- C) Bidder must quote the product as per specification provided in **Annexure-1**. The refilling should be guaranteed for a period of 12 months from the date of refilling and necessary certificate in this regards should be furnished.
- D) Rates must be quoted in Indian rupees and as per the format specified taxes extra if any must be written separately.
- E) Rates must be quoted FOR basis (including Freight charges, Insurance etc.)
- F) No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
- G) The rates quoted must be valid for 90 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
- H) Becoming L1 will not be the criteria for awarding of purchase order unless the rates are reasonable & justified.
- The firm/agency may satisfy the following conditions and attach self-attested copy of the same with the quotation:-
  - Firm shall be registered with the Government of Odisha / Central Government.
  - The firm shall have valid GST and PAN No.
  - The firm should have similar experience of supplying of the items in Govt. /PSU.
  - The firm should not be black listed by any Govt. Agency/Dept.

goods and after inspection by the OCAC Officials.

N) Accessories required in price bid as specified in Annexure I will be purchased as per

site requirement & calculated accordingly.

0) OCAC reserves the right to increase or decrease quantity and / or amount of work.

P) OCAC reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. Decision of the OCAC will be final
