

Introduction:

Odisha Computer Application Centre (OCAC) invites competitive bid proposals from interested firms who have experience in doing Al Anchoring, using technologies such as natural language processing, speech synthesis, and computer vision to generate realistic and human-like speech and movements at Janata Maidan Bhubaneswar, for TWO session in between 3rd Feb 2024 to 5th Feb 2024 for the "World Odia Language Conference-2024".

Tech Specifications for the Requirement:

- 1. Natural Language Processing (NLP) with Voice Cloning
- 2. Machine Learning (ML) Algorithms for Dynamic Voice Adaptation
- 3. Speech Recognition and Voice Command Integration
- 4. Computer Vision for Lips syncing

The agencies are expected to use their creativity and suggest suitable AI Anchoring according to need and theme of the event.

Eligibility Criteria:

Eligibility Criteria for Start-up

- 1. As per the eligibility criteria stipulated by DPIIT (Department for Promotion of Industry and Internal Trade) for the entities to qualify as a Start-up.
- 2. It should be an Indian firm /company.
- 3. All companies that meet the qualifying requirements must possess a valid Startup Odisha recognition certificate.
- 4. It is incorporated as a private limited company (as defined in the Companies Act, 2013) or registered as a partnership firm (registered under section 59 of the Partnership Act, 1932) or a limited liability partnership (under the Limited Liability Partnership Act, 2008) in India.
- 5. The company/firm must neither be a foreign company nor a subsidiary of any foreign or Indian company.
- 6. It should not be formed by splitting, up or reconstructing any existing business/company.
- 7. It should have obtained the "Certificate of Recognition" as a Start-up' from the Ministry of Commerce and Industry (Department of Industrial Policy and Promotion) either as per Notification Number G.S.R. 180 (E) dated 17th February, 2016 or G.S.R. 501(E) dated 23rd May, 2017, or G.S. R 127 (E) dated 19/02/ 2019 OR it should be in the process of applying for the same, and will submit the certificate before the formal engagement with the OCAC.
- 8. The firm /company should be a Start-up' as on date of signing the contract with the OCAC while engaging for any product / service/solution from them.
- 9. Start-up is either working towards innovation, development or improvement of products or processes or services or provide solutions that can further the financial inclusion in a significant way, or it is a scalable business model with a potential of generating employment.
- 10. It should not be older than 10 years from the date of its incorporation / registration.

- 11. The turnover of the firm/company should not have been greater than Rs. 100 crores in any of the years of its operations.
- 12. The Agency should be a registered firm having valid GST and PAN registration. Necessary documents should be submitted in this regard in the Bid Document.

Eligibility Criteria For Agencies/Tech Companies (Other Than Start-up)

- 1. The Agency must have experience in doing Al Anchoring. Proof to be attached. Agency having National & International level experience shall be given preference. (Copy of the work-orders & experience for successful event management through Al to be submitted in the General & Technical Proposal).
- 2. Agency must have an average annual turnover of ₹20 Lakhs for last three financial years ending with March 2023, in the field of event management. Proof to be submitted. (Copy of the CA certificate to be provided).
- 3. Conditional Bids shall not be considered and will be out-rightly rejected at the very first instance.
- 4. OCAC reserves the right to accept or reject any bid without assigning any reason thereof and OCAC's decision in this regard will be treated as final.
- 5. Un-signed & un-stamped bid shall not be accepted.
- 6. Undertaking for subsequent submission of any of the document asked in the tender will not be entertained under any circumstances. However, OCAC reserves the right to ask clarifications on the already submitted documents.
- 7. Over-writing/over-typing or erasing of the figures are not allowed and shall render the tender invalid.

Necessary supporting documents on fulfilment of terms & conditions should be attached for authentication along with a signed copy of the tender document to indicate acceptance of all terms and conditions set forth in the tender. Organizations failing to provide complete information on any of the requirements are liable to be rejected.

Submission of Bids:


Interested agencies are invited to submit the bids with and financial proposals in sealed envelope super scribed as 'Engagement of Al Anchor' for World Odia Language Conference-2024 at Janta Maidan Bhubaneswar.

Each of these bids to be submitted in two separate sealed envelopes and should be marked as "General & Technical bid" and "Financial bid" respectively. Further these two envelops should be enclosed in the main envelope super scribed as "Engagement of Al Anchor for World Odia Language Conference-2014 at Janta Maidan Bhubaneswar".

Bid Evaluation and Selection Criteria:

All the bidders who qualify the eligibility criteria shall be invited to make a short power point presentation of their proposed solution for the event on **31-01-2024**. These solutions will be evaluated by OCAC committee. Based on the solution and the presentation agencies will be

shortlisted. The decision of the evaluation committee shall be final & binding. One agency can submit only one proposal

The financial bid shall be opened only for those bidders, whose solution is/are shortlisted. Subsequently OCAC may modify the scope according to the need and requirement of OCAC and E&IT Department without additional cost. Out of the best solution shortlisted the agency with least cost (L1) will be considered for final selection.

OCAC may negotiate with the selected agency on financial bid and the work order will be awarded to the agency upon agreement of the final cost by both the parties.

Other Terms & Conditions:

- 1. Price must be mentioned inclusive of all taxes and Transportation.
- 2. The supplied AI must be of top quality.
- 3. The work/job has to be completed before 01.02.2024, 10: 00 AM/PM. If the job will not complete within stipulated period of time), the OCAC Authority would have a right to done the same job from the market and the cost incurred by OCAC will be borne by the firm/agency.
- 4. The price quoted should be firm and final.
- 5. Bid should be valid for 30 days from the specified date of closing.
- 6. Transportation will be at Suppliers risk.
- 7. The price offer through E-mail/Fax will neither be accepted nor entertained.
- 8. The firms/agencies must sign on each page of quotation documents with date and seal & to be submitted.
- 9. Payment: 100% after successful supply and completion of the event program.
- 10. Interested Firms/Agencies may quote their competitive price and other terms and conditions.
- 11. Bids once submitted shall not be withdrawn. Any default after acceptance of the bid shall be deemed to be non-compliance to the terms of contract and cancellation of contract.
- 12. The bidder shall be responsible for due payment of all applicable taxes, duties, levies changes and expenses with respect to or arising out of performance of this work/job. The contractor has to ensure all required statutory compliance including IT, ST, PF, ESI, Labor License, Work man Compensation, Payment of Minimum Wage etc. as in force.
- 13. In case of any dispute, the decision of General Manager (Admn.) shall be final and binding on you.
- 14. Incomplete offer or communication after due date and time will be rejected.




