10. Scope of work

10.1 Purpose

The Odisha Computer Application Centre (OCAC) is seeking proposals from reputable bidders for the supply of 900 5G Android Mobile Handset (The actual number may vary depending on the requirement of the ULBs) with Screen Guard and Back Cover and 900 SIM card to Core Sanitation Workers for Housing & Urban Development Department, Govt. of Odisha for 2 Years. During this two-year period, if any additional 5G android mobile handsets and SIM cards are required by the ULBs or the Housing & Urban Development Department, the selected bidder shall supply them at the final quoted price as derived in the financial bid.

The details of the ULB locations along with the receiver details for mobile handset delivery will be provided by the Housing & Urban Development Department to the selected vendor.

Additionally, information regarding the users (i.e., core sanitation workers) who will be using the mobile handsets with SIM cards will also be shared by the department, in the format required by the SIM service provider/selected vendor for the SIM registration process.

10.5 Warranty

The mobile handsets to be supplied under this Request for Proposal (RFP) must carry a minimum warranty period of one (1) year and another 1 year of extended warranty, which shall also cover the battery.

A separate field for the cost of an additional one-year extended warranty for the mobile handsets, including the battery, has been included in the financial bid to determine the overall cost, considering the two-year project duration. However, the decision to avail this extended warranty will be made by the department at a later stage.

For SIM cards, required service continuity for 24 months from activation as the project duration is two years and in case of any damage to the SIM, a replacement SIM card with the same number and features must be provided at no additional cost.
